## [Melvor Idle Mod Competition 2023]

### THE COMPETITION

- 1.1 The promoter and organiser of this competition is Jagex Limited of 220 Cambridge Science Park, Cambridge, England, CB4 OWA ("Jagex", "us" or "we"). These terms and conditions govern the legal relationship between Jagex and you (referred to in these terms and conditions as "you", "yours" or "Entrant") in relation to the competition.
- 1.2 Please read these terms and conditions carefully, and in particular clause 6.2,6.3 and 6.4 regarding how we will handle your personal data in relation to the competition.
- 1.3 The title of the competition is [Melvor Idle Mod Competition 2023].
- 1.4 To enter the competition, you must develop and submit 1 (one) Modification related to Melvor Idle, a game developed by Games by Malcs PTY Limited ("Games by Malcs") and published by Jagex.
- 1.5 All information detailed on any of Jagex websites (including but not limited to jagex.com, hereafter referred to as "Jagex Websites"), digital platforms, games or apps or published in any of our newsletters in relation to the entry requirements for this competition form part of these terms. In the event of any discrepancy or conflict between that information and these competition terms, the specific competition terms and conditions will prevail.
- 1.6 Facebook (or any other social media site, with the exception of mod.io Pty Ltd. ("mod.io")) do not endorse or sponsor any competitions hosted by Jagex and we are not affiliated with Facebook in any way (or any other social media site).

#### 2 **HOW TO ENTER**

- 2.1 The competition will run from 00:01 BST on [14 June] to 23:59 BST on [5 July] (the "Closing Date") inclusive.
- 2.2 To enter the competition, Entrants must have an eligible modification (being a functioning alteration to the underlying function of Melvor Idle in accordance with these terms, hereafter "Modification") hosted on mod.io before the Closing Date. Modifications shall only be eligible if the creator has a single active member account on mod.io at the time of the Closing Date. Duplicate accounts will not accepted.
- 2.3 All competition entries must be received by Jagex before the Closing Date. All competition entries received after the Closing Date are automatically disqualified.
- 2.4 No purchase is necessary to enter the competition and there is no charge to register for use of a Jagex Website.

(these regions together the "Competition Jurisdiction") aged 18 years or older or the age of majority in their country of residence at the time of registration, except:

- 4.1.1 employees of Jagex, Games by Malcs or mod.io or either of their holding or subsidiary companies;
- 4.1.2 employees of agents or suppliers of Jagex, Games by Malcs, or mod.io or either of their holding or subsidiary companies, who are professionally connected with the competition or its administration;
